The Direct Debit Guarantee

- If there are any changes to the amount, date or frequency of your Direct Debit, (WRCDT) - Growing in Faith, will notify you 7 working days in advance of your account being debited or as otherwise agreed. If you request, (WRCDT) - Growing in Faith, to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by (WRCDT) - Growing in Faith or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
 - If you receive a refund you are not entitled to, you must pay it back when (WRCDT) - Growing in Faith asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
